

## PER-DISTRICT COMPARISONS OF MAEP, SENATE PLAN, AND HOUSE PLAN

## Nearly Every School District Loses with INSPIRE

The columns below provide a comparison of estimated per-district funding using the current MAEP formula, the Senate's proposed adjusted MAEP formula, and the House-proposed INSPIRE Act through FY2035. The far left columns indicate by year how quickly the MAEP and the Senate plan surpass the level of funding provided by the INSPIRE proposal. In year 1 (2024-2025 school year), the MAEP provides more funding to 82 school districts, 37 of which have the highest poverty rate possible in MDE's reporting (>=95%)\*. In year 1, the Senate plan provides more funding than INSPIRE to 66 school districts, 30 of them with a >=95% poverty rate. By year 3, school year 2026-2027, the MAEP outpaces INSPIRE in 117 districts (54 high-poverty), and the Senate plan exceeds INSPIRE in 110 districts (50 high-poverty).
